The City does NOT connect meter to building. Service line in excess of one (100') billed to homeowner at the rate of two (\$2) dollars per foot.

The minimum commercial/industrial connection fee, payable with application, for a new service is five hundred (\$500) dollars. The service connection will be installed on a time and material basis with any charges over five hundred (\$500) dollars billed to the property owner.

**Regardless of the classification of new or existing service, all natural gas plumbing on the customer's side of the meter must conform to the current National Fuel Gas Code before meter will be set.**
